MODE OF REGISTRATION

All Candidates are expected to register for October, 2010 Examination diet through the CIBN Website www.cibng.org
Candidates are to pay their examination fees and other levies on or before registering for the examination online.

ONLINE REGISTRATION PROCEDURE

- Log on to www.cibng.org
- Click on **Member login** on the left hand side
- Fill in your membership number and CIBN password
- Click on CIBN Examinations
- Click the subject(s) you are registering for
- For students who had written the Institute's examination before, click on the **diet, year** and **centre** of your last examination
- Click on "**proceed**"
- Pick a more suitable payment option from among **e-transact, Interswitch** or **e-wallet**
- After successfully making your payment, please print your Examination Docket with a bold **passport size 190x190 pixel, jpeg**
- Printed docket must be **authenticated** by either a Fellow, Associate, Honorary Senior Member of the Institute or Branch Manager of Banks

IMPORTANT NOTICES

- Registration for October Examination Diet will close at 12 noon on Friday 27 August, 2010
- Candidates will not have access to the Examination portal after Friday 27 August, 2010
- Candidates will need to contact the National Secretariat for any late registration which will attract a penalty of N10,000
- Candidates must ensure that payments for Examination are made into the Exam Portal as any Payment in error into other applications such as Exemption, Annual Subscription etc, instead of examination will not be reversed
- Applications for change of Examination Centre must be received by the Institute on or before Monday 20, September 2010
- Candidates are to ensure the accuracy of the information on their registration forms
- Passport photographs must be according to the specification in the online registration procedure above
