1.0 GOVERNANCE STRUCTURE

The Chartered Institute of Bankers of Nigeria (CIBN) is overseen by a Governing Council which comprises of elected and appointed members to serve for a period of two years. The Council is the highest policy formulation and decision-making body of the Institute while the Office Holders a body which includes the President/Chairman of Council, 1st Vice President, 2nd Vice President and the National Treasurer, oversee the Institute's activities and handles urgent issues on behalf of the Governing Council. The Executive Management led by the Registrar/Chief Executive is responsible for overall management and day- to- day operations of the Institute.

A full-fledged Secretariat was established to implement the Institute's policies, goals and objectives. The Secretariat also assists in developing and implementing strategies that will strengthen the mandate of the Institute as well as facilitate its operations. It also facilitates the dissemination of information to increase awareness and broad based participation.

The Committee has been striving to ensure the achievement of the Institute's major mandate through Curriculum Review and Development, Accreditation and Linkage Programmes, and Conduct of Examinations etc.

In light of the above, the Committee successfully accomplished the following:

- Accreditation and re-accreditation of one (1) academy and seven (7) bank academies to bring the total number of Academies/Learning Centers till date to twenty-two (22). In addition, graduates of these accredited Academies were granted exemptions thereby facilitating their early qualification as Professional Bankers (ACIB). The Academies/Learning Centres are being closely monitored to maintain the standards of the accreditation and ensure continuous compliance with the terms of the accreditation.
- Two (2) Tuition centres were re-accredited.
- A total of twelve (12) Educational Training Service Providers were accredited. Additionally, thirteen (13) Educational Training Service Providers were re-accredited in line with the provisions of the Competency Framework in the Nigeria Banking Industry.
- The Governing Council approved three (3) applications for Linkage Partnership as recommended by the Capacity Building & Certification Committee thereby increasing the number of institutions in the HND/BSc/ACIB Linkage Programme to seventy-nine (79) from seventy-six (76) in the previous year.
- The Committee closely monitored the administration, management and conduct of the examinations and other activities which include prompt publication of Examiners' Reports, monitoring of examinations at the various centres as Compliance Officers, monitoring of the activities of the other sub-committees.
- Maintaining the standard and integrity of all the Institute's examinations, including those

of Chartered-Banker MBA in collaboration with Bangor University, Wales and Chartered Institute of Bankers, Scotland.

- The array of resources persons was top-notch and were on point as anticipated.

- The Gen-Z & Innovation Committee following its inauguration in July of 2022 has been developing a Report/Strategy document to guide the Institute on new avenues towards attracting and keeping Gen-Z and millennial members. Content within the Roadmap includes the following:
- The Committee conducted a survey to gain insight into the public's awareness and participation level in the Chartered Institute of Bankers Nigeria (CIBN). The first survey was done with a total of 615 respondents. The survey report was presented to the Council with the following findings:

- Gen-Z & Millennial Awareness of The Chartered Institute of Bankers is high with over 96% responding positively.
- The high awareness of CIBN does not translate to high membership as 74.3% of participants polled are not members
- However, interestingly, 94% of respondents indicated that they are willing to join the CIBN
- Career progression, personal development and networking are the top three reasons for being willing to join the CIBN
- 34.5% of respondents were between 25-30 years of age
- 19.8% of respondents are between the ages 31-35 years of age.
- ❖ It is pertinent to note that the Gen-Z Committee held meeting every Thursday between August and October. For the rest of the year 2022, the Committee discussions were made on the WhatsApp platform. Furthermore, the Committee has met on five occasions in the first quarter of 2023.
